



Participation Conditions of the „Continental Memory“

1. Organizer of the „Continental Memory“

The organizer of the "Continental Memory" ("Memory") is Continental Automotive Romania SRL, Siemens Street, 1, 300704 Timisoara, Romania registered in the commercial registry of the district court Timisoara under the number J/35/229/2000, fiscal code RO 12817173, e-mail: career-auto-iasi@continental-corporation.com.

In particular, Facebook Germany GmbH or any company affiliated with it ("Facebook") is not the organizer of the competition. The competition is not linked to Facebook and is not sponsored, supported, or organized by Facebook in any way.

All questions, comments or complaints connected with the competition are to be directed to Continental Automotive Romania SRL (career-auto-iasi@continental-corporation.com). Participant claims against Facebook are not justified by the competition. The participant releases Facebook from any liability connected to the competition. The recipient of the information provided by the participants in the context of the competition is not Facebook but Continental Automotive Romania SRL. The information provided is used solely for the purpose of the competition. The sole contact partner and supervisor for planning, organizing, and carrying out the competition as well as creating the prizes is Continental Automotive Romania SRL, not Facebook.

2. Participation Requirements

2.1. Participation in the competition is only possible via the window in the "Memory" application from Continental AG at <https://www.continental-memory.com> or <https://www.continental-memory.de>.

2.2. All persons who are at least 18 years of age are entitled to participate. Upon registering, the participants must enter their civil first and last names in the context of the application. Participation under a false name or on behalf of another person is not permitted. In particular, employees of Continental Automotive Romania SRL, Siemens Street, 1, 300704 Timisoara, and of its affiliated companies and their relatives are not entitled to enter.

2.3. Participation in the competition takes place when the participant fills out the form given in the application within the term of the competition.

3. Competition Term and Prizes

3.1. The competition will take place during the CodeCamp event, starts on April 23, 2016, 08:00 a.m. CET and ends on April 23, 2016 at 6:00 p.m. CET. ("competition term").

3.2. At the end of the CodeCamp event, ten winners will be chosen amongst the participants based on their speed of response. They will be informed about the win during a meeting that will take place at the end of the CodeCamp event. Only one entry per person per day is allowed. If participants enter the competition in a manner contrary to the rules, this will result in their exclusion from the game.

3.3. Prizes: The respective prizes are presented on the booth of Continental at the CodeCamp event in Iasi 10 personalized laptop backpacks in total value of approximately 310 Euro, VAT excluded.

3.4. To communicate the win, Continental AG saves the addresses and names of the participants as part of this competition.

All data saved will be deleted by Continental AG within four weeks after the end of the competition and will not be forwarded to third parties.

4. Exclusion from the Competition

4.1. Participants who violate the participation conditions, make false entries or manipulate the application will be expelled from the competition with immediate effect. If grounds for exclusion are present, prizes can be revoked subsequently or reclaimed.

The organizer and/or the agencies commissioned with carrying out the competition, are entitled to discontinue, cancel or suspend the competition at any time, in particular if

- during implementation, Facebook's conditions of use change so that implementation would not be possible according to Facebook's applicable conditions or the competition is stopped by Facebook;
- an attempt at misuse through manipulation has been determined;
- proper implementation can no longer be ensured, especially in the event of a hardware or software malfunction, program errors, computer viruses or unauthorized interference by third parties as well as mechanical, technical or legal problems.

Continental Automotive Romania SRL is authorized to exclude from the competition any participant who does not provide evidence of complying with the requirements stated in Item 2.2 on request or who is suspected of violating these terms of participation, and possibly also to retroactively disallow their prize and to ask that the prize be returned.

6. Data Protection Declaration

Should one or more of the provisions in these Participation Conditions be ineffective or contain a loophole, the effectiveness of the remaining provisions is untouched hereby. Invalid provisions or those containing a loophole shall be maintained with valid content that comes closest to the content that would have been agreed on had the invalidity or the loophole been considered.
